### Welcome

Zimmer Biomet values your privacy and the protection of your Personal Data. This Zimmer Biomet Privacy Notice ("Notice") explains how we collect, use, share, transfer, and process information collected from or about you ("Personal Data") (as defined further below) by any subsidiary or affiliate of Zimmer Biomet Holdings, Inc. (collectively "Zimmer Biomet," "we," "our," or "us").

The Zimmer Biomet subsidiary or affiliate with whom you, your Healthcare Provider, or your patient is interacting or who owns and operates the Product or Service is, where applicable, the entity responsible for the collection and use of your Personal Data (known in some jurisdictions as the data controller). In some circumstances, if you do not want to provide us with your information, certain Products and Services may be unavailable to you. To the extent permitted by applicable law, by providing us your Personal Data or otherwise interacting with us, you are agreeing to this Notice. If you do not agree with our policies and practices, it is your choice not to use our Products and Services or otherwise engage with us.

If you provide Personal Data of anyone other than yourself, please note that you are responsible for complying with all applicable privacy and data protection laws prior to providing that information to Zimmer Biomet (including obtaining consent, if necessary and required).

# Purpose of this Privacy Notice

This Notice describes the types of Personal Data that Zimmer Biomet may collect or process, how we may use and disclose that Personal Data, and how you may exercise any rights you may have regarding the processing of your Personal Data. This Notice applies to Personal Data collected or processed by us.

Some examples of instances where we collect Personal Data include:
